**ACKNOWLEDGEMENT OF SECURITY INTEREST

WHEREAS, pursuant to that certain Second Amended and Restated Revolving/Term Loan Agreement dated as of May 5, 2008, entered into by and among Borrower, the lenders from time to time who are parties thereto (collectively, the "Lenders"), Goldman Sachs Credit Partners L.P., as Joint Lead Arranger, and Secured Party (as such agreement may from time to time be amended, extended, renewed, supplemented or otherwise modified, the "Loan Agreement"), the Lenders have agreed to provide Borrower with certain credit facilities. Pursuant to that certain Security Agreement and Trademark Security Agreement each dated October 20, 2004, entered into between GRC and Secured Party (as such agreements may from time to time be amended, extended, renewed, supplemented or otherwise modified), GRC granted Secured Party a security interest in, among other things, all general intangibles to secure the prompt payment, performance and observance of the obligations under the Loan Agreement and related Loan Documents (as defined in the Loan Agreement),

WHEREAS, the aforementioned security interest in all general intangibles included all right, title and interest in the above-identified Registered and Applied-for Trademarks together with the good will of the business symbolized by them and all common law rights in them; said security interest also included all proceeds related to the Registered and Applied-for Trademarks including but not limited to any and all causes of action past, present or future which may exist by reason of infringement thereof,

WHEREAS, Borrower has agreed that all Obligations (as defined in the Loan Agreement) of GRC under each of the Security Agreement and Trademark Security Agreement shall continue as Obligations (as defined in the Loan Agreement) of Borrower, and

WHEREAS, Borrower and Secured Party desire to have a recordable document evidencing such security interest.

NOW, THEREFORE, in consideration of the foregoing recitals, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Borrower hereby confirms that it previously granted to Secured Party a security interest in the above-identified Registered and Applied-for Trademarks and other intellectual property.


