Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title and interest in and to the Trademarks in the United States, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within the United States based in whole or in part upon the Trademarks and any priority right that may arise from the Trademarks), and in and to all causes of action, either at law or in equity, and to the right to sue, counterclaim and recover for past, present or future infringement of the rights assigned herein, the same to be held and enjoyed by Assignee as fully and entirely as such interest would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record the transfer of the registrations and/or applications for registration set forth on Schedule A to Assignee as assignee of Assignor's entire right, title and interest therein. At Assignee's direction and expense, Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

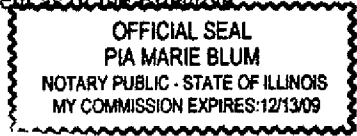
