THIS TRADEMARK ASSIGNMENT AGREEMENT is made the 4th day of October 2007 by and between:

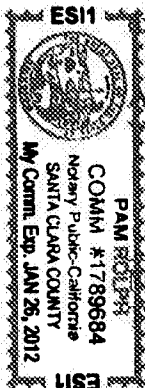

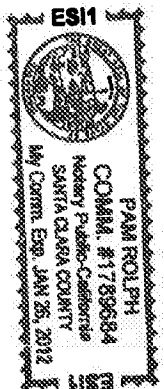
