**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
INTERNATIONAL METAL SERVICE NORTH AMERICA, INC.,
an Alabama Corporation**

Pursuant to the provisions of Sections 10-2B-10.01 through 10-2B-10.09 of the Code of Alabama 1975, as amended, the undersigned corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation (the "Articles"):

FIRST: The name of the Corporation is International Metal Service North America, Inc.

SECOND: For the purpose of changing the name of the Corporation, the Articles shall be amended to provide for a new ARTICLE I as follows:

ARTICLE I

NAME

The name of said corporation shall be "Astralloy Steel Products, Inc."

THIRD: The amendment was adopted by the Board of Directors and the sole shareholder of the Corporation on June 1, 2005.

FOURTH: The number of shares of each voting group outstanding, the number of shares of each voting group entitled to vote on the amendment, and the number of shares entitled to vote as a voting group on the amendment at the time of its approval were:
