CORRECTIVE ASSIGNMENT

WHEREAS, Health Innovations, Inc., a corporation of Delaware, had its principal place of business at 13873 Park Center Road, Herndon, Virginia 22071 (hereinafter referred to as "Assignor"), has adopted and used the trademark/service mark LIFESIGN to identify ELECTRONIC HANDHELD COMPUTERS FOR USE IN HELPING INDIVIDUALS TO STOP SMOKING AND ACCOMPANYING INSTRUCTION BOOKLETS SOLD AS A UNIT THEREWITH in commerce and interstate commerce in the United States since at least as early as January 15, 1986.

WHEREAS, on June 12, 1987, Assignor filed an application to register the mark LIFESIGN in the United States Patent and Trademark office and assigned Serial No. 74/666,184, which application issued on June 7, 1988, as U.S. Registration No. 1,490,885;

WHEREAS Assignor claims to have owned the entire right, title and interest in and to the trademark LIFESIGN, including the common law rights arising from Assignor's use of the mark in commerce in the United States, as well as all rights in and to the United States trademark application and registration relating to such mark and the goodwill of the business associated therewith;

WHEREAS, PICS, Inc., a corporation of Delaware, with a principal place of business at 12007 Sunrise Valley Drive, Reston, Virginia, 20191 (hereinafter referred to as "Assignee"), obtained Assignor's ownership rights, of whatever kind or nature, in and to the mark LIFESIGN, including any common law rights, the United States trademark

application and registration relating thereto, and the goodwill of the business associated therewith;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned and transferred to said Assignee, its successors, assigns and legal representatives, nunc pro tunc, as of the date of first use of the mark, the entire right, title and interest in and to the trademark LIFESIGN, including any and all common law rights in the mark, the United States trademark application and registration relating thereto, and the goodwill of the business associated therewith, together with all rights of action accrued under and by virtue hereof, including the right to sue and recover for past infringement of said trademark.
