**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE, dated as of this 27th day of June, 2008, given by Bank of America, N.A., as Second-Lien Collateral Agent, (the "Assignor") with principal offices at Mailcode NC1-001-15-04, 101 North Tryon Street, Charlotte, NC 28255, to ESRMCO, Inc., a Delaware corporation (together with any successors-in-interest to the Marks, the "Assignee"), having an address at 14 Par la Ville Road, Hamilton HMJX, Bermuda, as follows:

**WITNESSETH**

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor hereby releases and discharges its security interest, and quit claims, reconveys, and relinquishes unto the Assignee all of its right, title and interest, in the Trademark Collateral granted to Assignor by the Assignee pursuant to the Trademark Security Agreement, which Trademark Security Agreement was duly recorded on April 6, 2004, at Reel/Frame 2945/0325 in the United States Patent and Trademark Office.

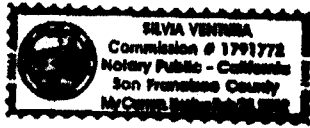

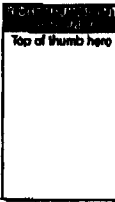
