**ASSIGNMENT OF TRADEMARK APPLICATION AND TRADEMARK UPON
APPROVAL OF TRADEMARK APPLICATION**

SECTION I

Upon submittal of proof of payment, Assignee also agrees to reimburse Assignor for costs incurred to date for the registration of the trademark, up to \$1,500.

SECTION II

Assignor hereby agrees to do, execute and perform such other acts, documents and things as the Assignee may reasonably request in order to give full force and effect to the true meaning and intent of this Assignment, including but not limited to executing such documents as may be necessary or desirable to register, record, perfect or file the assignment of the trademark application with public officials and governmental authorities.

SECTION III

This Assignment shall enure to the benefit of and be binding upon the heirs, executors, successors and assigns of Assignee.
