IP SUPPLEMENT NO. 9


This **IP SUPPLEMENT NO. 9**, dated as of July 15, 2008, is delivered by Hexcel Corporation, a Delaware corporation located at Two Stamford Plaza, 16th Floor, 281 Tresser Blvd., Stamford, CT 06901 (the "**Grantor**"), to Deutsche Bank Trust Company Americas, as Administrative Agent and representative of the Beneficiaries (in such capacity, the "**Secured Party**"), pursuant to and in supplement of (i) the Security Agreement, dated as of March 1, 2005 (said Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the "**Security Agreement**"), among Grantor, the other grantors named therein, and Secured Party, (ii) the Grant of Patent Security Interest, dated as of March 1, 2005, among Grantor, Hexcel Reinforcements Corp. and Secured Party, and (iii) the Grant of Trademark Security Interest, dated as of March 1, 2005, between Grantor and Secured Party (collectively, together with all IP Supplements entered into since March 1, 2005, the "**Grants**"). Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Grants.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by Grantor to Secured Party pursuant to the Security Agreement, Grantor grants to Secured Party a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral and Patent Collateral set forth on Schedule A annexed hereto. All such Trademark Collateral and Patent Collateral shall be deemed to be part of the Trademark Collateral and Patent Collateral, respectively, and shall be hereafter subject to each of the terms and conditions of the Security Agreement and the Grants.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral and Patent Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

IN WITNESS WHEREOF, Grantor has caused this IP Supplement No. 9 to be duly executed and delivered by its officer thereunto duly authorized as of the date hereof.
