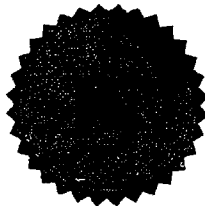

**First.** The Certificate of Formation of American Campus Lifestyles Companies, L.L.C. was filed with the Secretary of State of the State of Delaware on October 8, 1993. An Amendment to the Certificate of Formation was filed on February 17, 1998 changing the name of the limited liability company to American Campus Communities, L.L.C.

**Second.** The name of the limited liability company immediately prior to filing this Certificate of Conversion was American Campus Communities, L.L.C.

**Third.** The name of the corporation as set forth in the certificate of incorporation of the corporation converted hereby is American Campus Communities Services, Inc.

**Fourth.** American Campus Communities, L.L.C. is a limited liability company formed and existing under the laws of the State of Delaware.

**Fifth.** The units of membership interest of American Campus Communities, L.L.C. shall convert into 1,000 shares of common stock of American Campus Communities Services, Inc. on a pro rata basis upon the filing of this Certificate of Conversion and the Certificate of Incorporation of American Campus Communities Services, Inc.
