**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of July 9, 2008, is made by Morgan Stanley Senior Funding, Inc. ("Morgan Stanley"), in favor of Vanguard Plastics, Inc. ("Vanguard") as follows:

Morgan Stanley agrees to provide Vanguard with any information and additional authorization necessary to effect the release of Morgan Stanley's security interest in the released Trademark Collateral.


