"The name of this corporation is AZTEC MANUFACTURING, INC."

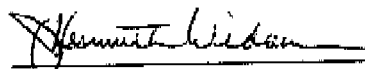
3. The foregoing amendment of the articles of incorporation has been duly approved by the board of directors.
