**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**





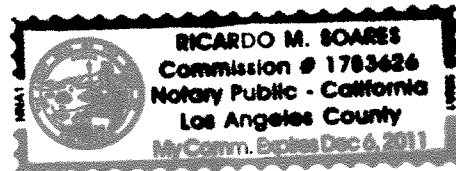
