RELEASE OF SECURITY INTEREST (TRADEMARKS)

THIS RELEASE OF SECURITY INTEREST (TRADEMARKS)("Release") is made as of the date of signature set forth below ("Effective Date") by **SUNWEST BANK** as assignee ("Assignee") under that certain **COMMERCIAL SECURITY AGREEMENT** ("Security Agreement") dated November 1, 2002 between **GRANDE FOODS** ("Assignor"), predecessor in interest to **SOH IP COMPANY, INC.** ("SOH IP"), and Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby acknowledges and covenants that the Security Agreement has been and is terminated, and re-pledges, reassigns and releases in favor of SOH IP any and all security interests or other rights Assignee has against the Trademarks, without warranty or recourse.

If and to the extent the Assignee has acquired any right, title or interest to any of the Trademarks, Assignee hereby assigns and transfers such right, title and/or interest to SOH IP along with any goodwill in the Trademarks that Assignee may have acquired.

The Assignee shall, at SOH IP's expense, take all further actions, and provide to SOH IP and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by SOH IP to fully and effectively effectuate the purposes of this Release.

Section 1746(2), the undersigned declares that the foregoing is true and correct to the best of his/her knowledge and belief.
