**FIRST AMENDMENT TO
TRADEMARK SECURITY AGREEMENT**

This First Amendment to Trademark Security Agreement, effective as of July 8, 2008 (the "*First Amendment*") is by and between HUNTER'S SPECIALTIES, INC., an Iowa corporation (the "*Corporation*"), and MIDWEST MEZZANINE FUND III, L.P., a Delaware limited partnership ("*Midwest*"), as collateral agent (in its capacity as such, the "*Agent*") on behalf of Midwest and CENTERFIELD CAPITAL PARTNERS, L.P., a Delaware limited partnership ("*Centerfield*", together with Midwest, the "*Senior Subordinated Lenders*").

RECITALS

A. The Corporation and the Senior Subordinated Lenders have heretofore entered into that certain Trademark Security Agreement dated as of July 8, 2003 (the "*Trademark Security Agreement*").

B. The Corporation has informed the Agent that the Corporation now owns certain additional Trademarks as shown on the attached Exhibit A.

C. Pursuant to the authority granted in Section 5 and Section 15 of the Trademark Security Agreement, the Agent has been authorized by the Corporation to amend the Trademark Security Agreement by replacing Schedule A to the Trademark Security Agreement (the "*Current Schedule A*") with Schedule A attached hereto (the "*Replacement Schedule A*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby amends Schedule A to the Trademark Security Agreement by substituting the Replacement Schedule A in place of the Current Schedule A.

This First Amendment shall be governed by the internal laws of the State of Illinois and applicable federal law. Except as modified hereby, no other changes or modifications to the Trademark Security Agreement are intended or implied and the Trademark Security Agreement amended by this First Amendment shall be read and construed as one agreement.


