EXHIBIT A

TRADEMARK ASSIGNMENT

This Trademark Assignment is executed and delivered pursuant to that certain Trademark Settlement Agreement dated as of 15th July, 2008 (the "Agreement") by and among FORTENT LIMITED, a United Kingdom company with a business address of 18 Mansell Street, London, E1 8AA, England (formerly of Prospect House, 80-110 New Oxford Street, London, WC1 A1HB, England) ("Fortent"), and FIDESSA LATENTZERO LIMITED, a United Kingdom company with a business address of 1 Alfred Place, London, WC1 E7EB, England ("FLZ").

WHEREAS, Fortent has adopted, used and is using the mark SENTINEL (the "Mark") for which registrations have been issued (the "Registrations") by the Office for Harmonization in the Internal Market (OHIM) and the United States Patent and Trademark Office (USPTO), as listed on the attached Exhibit A; and

WHEREAS, pursuant to the terms and conditions of the Agreement, Fortent has agreed to assign and transfer, and FLZ has agreed to purchase the Mark and Registrations.

NOW, THEREFORE, for good and valuable consideration as specified in the Agreement, receipt of which is hereby acknowledged, Fortent agrees as follows:

1. Fortent hereby assigns and FLZ accepts
 - (i) All right, title and interest in and to the Mark and Registrations, together with the goodwill attached to the Mark
 - (ii) The benefit of any rights at common law or otherwise which have accrued to the Assignor through use of the Mark and Registrations, to hold the same unto the Assignee absolutely.
2. The assignment of the Mark and the Registrations to FLZ shall include the transfer of any accrued claims or causes of action against third parties.
3. Fortent hereby and appoints FLZ and its successors and assigns as the true and lawful attorney-in-fact of Fortent, with full power of substitution, to institute and prosecute all proceedings, sign and record all documents and instruments, and generally take all other action, in the name of Fortent or otherwise, that FLZ may deem proper solely for the purpose of collecting, asserting or enforcing any claim, right or title of any kind in or to the Mark or to more effectively transfer, convey and assign to FLZ and confirm FLZ's title to the Mark. Once title has been duly recorded as transferred, this appointment ceases forthwith.
4. Fortent will, for no further consideration, execute, acknowledge and deliver all such confirmatory documents and other instruments of assignment as FLZ may reasonably request to vest the Mark in FLZ and its successors and assigns.

5. This Assignment shall be governed by and construed in accordance with the laws of England, and the parties agree to submit to the exclusive jurisdiction of the English Courts as regards any claim or matter arising in relation to this Assignment.
