Pursuant to the provisions of Section 14A:9-2(4) and 14A:9-4(3) of the New Jersey Statutes Annotated, the undersigned corporation executes the following Certificate of Amendment to its Amended and Restated Certificate of Incorporation:

1. The name of the corporation is CGI NORTH AMERICA, INC. (the "Corporation").
2. The following amendment to the Corporation's Certificate of Incorporation, as amended, was approved by the unanimous written consent of the directors of the Corporation and thereafter duly adopted by the written consent of the sole shareholder of the Corporation on December 28, 2007.
