3. Article IV of the Articles of Incorporation of this corporation is amended to read as follows:

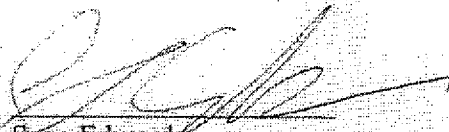
The corporation is authorized to issue only one class of shares of stock; and the total number shares which this corporation is authorized to issue is Fifteen Million (15,000,000).


4. The foregoing amendments of the Articles of Incorporation has been duly approved by the board of directors.

5. The foregoing amendments of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 8,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
