**TRADEMARK RELEASE**

This Release is granted as of the 18th day of July 2008, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Secured Party ("Secured Party"), to BAYER CLOTHING GROUP, INC., a Pennsylvania corporation ("Bayer") and GREENWICH TRIANGLE LLC (formerly SOUTHWICK CLOTHING LLC), a Massachusetts limited liability company ("Greenwich Triangle" and together with Bayer, the "Debtor"), as follows:
