WHEREAS, Assignor, Assignee, CPQ Holding Corporation, a Delaware corporation, INEOS Group Ltd., a company organized under the Laws of England and Wales, INEOS Holdings (Fluor & Silicas) Ltd., a company organized under the Laws of England and Wales, INEOS Silicas Holdings Ltd., a company organized under the Laws of England and Wales, INEOS Silicas Netherlands BV, a company organized under the Laws of The Netherlands, and INEOS Americas LLC, an Alabama limited liability company, are parties to the Purchase Agreement, dated as of October 11, 2007 ("Agreement"), providing for the execution and delivery of this Assignment by Assignor to Assignee (capitalized terms used herein without definition shall have the meanings set forth in the Agreement);

WHEREAS, Assignor has adopted, used or is using the marks set forth on <u>Schedule I</u> and incorporated by reference herein, which are registered, or for which application for registration has been filed, in the United States Patent and Trademark Office (collectively, the "<u>Assigned Marks</u>"); and

WHEREAS, Assignee desires to purchase all Assignor's right, title and interest in and to the Assigned Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

Assignor does hereby sell, assign, and transfer to Assignee with effect from the date of this Assignment (i) all right, title and interest of Assignor in and to the Assigned Marks, the registrations and applications for registration thereof, including all rights arising under common law and by statute, and the goodwill connected with the use thereof and symbolized thereby, together with all rights and privileges pertaining to the Assigned Marks, including rights of renewal of registrations thereof for subsequent terms, free and clear of all Liens, other than Permitted Liens; (ii) all rights of priority therein in any country as may now or hereafter be granted to it by law, treaty or other

international convention; (iii) all rights and obligations of Assignor under licenses in or under the Assigned Marks; the same to be held and enjoyed by Assignee as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; and (iv) all rights, interests, claims and demands recoverable in law or equity that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Marks, including without limitation the right to compromise, sue for and collect such profits and damages; the same to be held and enjoyed by Assignee, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Following the Closing, Assignor shall, and shall cause its Affiliates and its Affiliates' representatives to, at the expense of Assignee, execute and deliver such additional instruments, documents, conveyances or assurances and take such other actions as shall be necessary, or otherwise reasonably be requested by Assignee, to confirm and assure the rights and obligations provided for in this Assignment and the Agreement and render effective the consummation of the transactions contemplated hereby and thereby, or otherwise to carry out the intent and purposes of this Assignment and the Agreement.

This Assignment shall be governed by, and construed in accordance with, the laws of the United States, in respect to trademark issues and in all other respects, including as to validity, interpretation and effect by the laws of the State of New York, without giving effect to the conflict of laws rules thereof.

This Assignment is not intended to confer upon any person other than the parties hereto any rights or remedies.

This Assignment may be executed in any number of counterparts (including via facsimile or electronic copy), each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.




