
**WHEREAS**, ASSIGNEE is a successor to the business of the ASSIGNOR to which the MARKS pertain.

**NOW, THEREFORE**, in consideration of the Purchase Price (as defined in the Purchase Agreement) and other good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which hereby is acknowledged, ASSIGNOR does hereby assign, sell, transfer and convey unto ASSIGNEE its entire right, title and interest in and to the MARKS, and to the applications and/or registrations for the MARKS, together with the goodwill of the business symbolized by and associated with the MARKS and the registrations thereof, and the portion of the business of the ASSIGNOR to which the MARKS pertain, including the right to sue for and collect damages incurred as a result of any past, present or future infringement, misappropriation or violation of rights related to the MARKS.
