RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Aqua2 Acquisition, Inc. ("Aqua2") is the owner of the trademarks and service marks listed on Schedule A, attached hereto, which marks are registered or have pending registrations in the United States Patent and Trademark Office (all such trademarks, service marks, registrations and applications, collectively, the "Trademarks"); and

WHEREAS, in order to secure certain indebtedness, Automotive Franchise Systems LLC (the "Pledgor") entered into a Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of December 4, 2003, in favor of Bank One N.A. (now known as JPMorgan Chase, N.A.) (the "Bank"), with offices at 28660 Northwestern Highway, Mail Code MI 1-8937, Southfield, Michigan 48034, and pursuant thereto the Pledgor executed and delivered the Security Agreement as recorded in the United States Patent and Trademark Office on December 16, 2003 in Reel 2764, Frame 0664 and in Corrective Assignment filing made by JPMorgan Chase, N.A. recorded on July 21, 2006 in Reel 3370, Frame 0837, pursuant to which Pledgor granted to the Bank, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks;

WHEREAS, all obligations of the Pledgor under the Security Agreement were fulfilled:

WHEREAS, Aqua2 acquired all right, title and ownership in those Trademarks listed on the attached Schedule A by way of a Trademark Assignment by and between Pledgor, Aftermarket Experts LLC and Aqua2 as recorded in the United States Patent and Trademark Office on February 22, 2008 in Reel 3722, Frame 0811; and

WHEREAS, in order to ensure clean title for Aqua2 as the new owner on the Trademarks listed on the attached Schedule A, Aqua2 has requested that this Release of Grant of Security Interest in Trademarks be executed by the Bank in accordance with the terms of the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank does hereby release and relinquish, without representation or warranty, all of the Bank's security interest in and to all right, title and ownership in the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Security Agreement in the United States Patent and Trademark Office as aforesaid may be removed of record.
