ASSIGNMENT OF TRADEMARK

WHEREAS, HCA Health Services of New Hampshire, Inc., a corporation duly organized and existing under the laws of the state of New Hampshire, with its principal place of business at 9 Capitol Street, Concord, New Hampshire 03301 (“Assignor”), is the sole owner of the exclusive right, title and interest in and to the following Mark, along with the corresponding Registration thereof, and has used and is currently using the Mark in connection with “health care services, hospital services and medical services, namely, inpatient, outpatient, and acute care; and providing surgical, obstetrical, cardiology, emergency, rehabilitation, pediatric, and oncology and hematology services” (hereinafter referred to as “the Mark”):

The entire and exclusive right, title and interest in and to the Mark, together with the goodwill of the business connected with the use of and symbolized by the Mark, including, without limitation, any applications and registrations therefore, any renewals and extensions of the registration, the right to register the Mark in Assignee’s name throughout the world, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee’s own use and enjoyment, and for the use and enjoyment of Assignee’s successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter; and

2. The sole right to enforce all rights in and to said Mark, with the right to sue for and recover for Assignee’s own use accrued profits or damages for any and all causes of action, claims, and demands and other rights for infringements thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, said HCA Health Services of New Hampshire, Inc., does hereby assign unto said C/HCA, Inc., all rights, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark and the corresponding registration thereof.

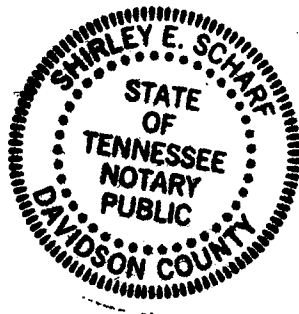
