RELEASE OF SECURITY INTEREST

WHEREAS, Mid State Machine Product (the "Debtor") is the owner of trademarks listed on Schedule 1, annexed hereto and made a part hereof (the "Trademarks") and the goodwill of the business associated therewith, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of the infringement thereof (the "Collateral"; the Trademarks and the Collateral collectively referred to as the "Intellectual Property");

WHEREAS, by an agreement between General Electric Capital Corporation ("GE") and the Debtor, dated February 1, 2002 and recorded in the United States Patent and Trademark Office ("USPTO") on February 7, 2002 at Reel 2451 Frame 0102 ("GE/Mid State Agreement"), Debtor granted to GE a security interest in and to, *inter alia*, the Intellectual Property;

WHEREAS, by an agreement between GE and Ableco Finance LLC (the "Secured Party"), dated July 31, 2003 and recorded in the USPTO on August 14, 2003 at Reel 2801 Frame 0455 ("Ableco/GE Agreement"; the Ableco/GE Agreement and the GE/Mid State Agreement collectively referred to as the "Security Agreements"), GE assigned its security interest in and to, *inter alia*, the Intellectual Property to the Secured Party;

WHEREAS, the Secured Party no longer claims a security interest in the Intellectual Property under the Security Agreements;

NOW, THEREFORE, the Secured Party and Debtor hereby agree as follows:

1. The Secured Party hereby expressly releases and discharges on behalf of itself, its successors, legal representatives and assigns, the security interest in, to and under the Intellectual Property of the Debtor pursuant to the Security Agreements.
2. The Secured Party has no right, title, claim, lien or other interest in the Intellectual Property pursuant to the Security Agreements.
3. The Secured Party hereby authorizes and requests the Commissioner of Patent and Trademarks of the USPTO to record this Release Of Security Interest with regard to the Security Agreements.
