## **CONFIRMATORY AND AMENDED ASSIGNMENT OF TRADE-MARKS**

**WHEREAS** by assignment dated May 30, 2008 (the “May 30<sup>th</sup> Assignment”) the predecessor of 145ES (Canada) Limited (the “Assignor”), then existing as Unipac Corporation, and subsequently existing as the amalgamated entity 145ES (Canada) Corp. and now, as a result of a further amalgamation, existing as the Assignor, a limited liability company existing and governed under the laws of the Province of Nova Scotia, the full post office address of whose principal office or place of business is 10 Carlow Court, Unit 2, Whitby, Ontario, Canada, L1N 9T7, assigned its entire right, title and interest in and to certain trade-marks, applications and registrations, including the applications and registrations listed in Schedule A attached hereto (the “Assigned Trade-marks”);

**AND WHEREAS**, Wynn’s Canada Ltd. (the “Assignee”), a company incorporated and governed under the laws of Canada, the full post office address of whose principal office or place of business is 7090 Edwards Blvd, Mississauga, Ontario, L5S 1Z1, wishes to confirm the assignment of the Assigned Trade-marks and is desirous of acquiring the Assignor’s whole right, title and interest in and to the trade-marks listed in Schedule B attached hereto and the Goodwill associated therewith;

**AND WHEREAS** the schedule to the May 30<sup>th</sup> Assignment contained certain trade-mark applications and registrations in error and Assignor and Assignee are desirous of correcting these errors and confirming that the Assigned Trade-marks were assigned to Assignee under the May 30<sup>th</sup> Assignment;

**AND WHEREAS** the schedule to the May 30<sup>th</sup> Assignment omitted certain trade-mark applications and registrations that Assignor intended to assign to Assignee, and Assignee is desirous of obtaining all of Assignor’s right, title and interest in and to these trade-marks, which are listed in Schedule B attached to this Confirmatory and Amended Assignment of Trade-marks.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties hereto, Assignor hereby confirms that it has sold, assigned and transferred unto Assignee, its successors and assigns, effective May 30, 2008, all of Assignor’s right, title and interest in and to the Assigned Trade-marks as set out in Schedule A in the jurisdictions listed therein and the Goodwill attached thereto, and hereby sells, assigns and transfers unto Assignee, its successors and assigns, effective May 30, 2008, all of Assignor’s right, title and interest in and to the trade-marks listed in the attached Schedule B and the Goodwill associated therewith, together with all rights of action resulting from any adverse use of these trade-marks or any confusingly similar trade-marks and the right to claim such relief as is appropriate, the same to be held by Assignee, its successors and assigns as the same could have been held and enjoyed by Assignor if the sale, assignment and transfer had not been made.

The parties agree to do or cause to be done all acts or things necessary to implement and carry into effect this assignment to its full extent.

This agreement may be executed in counterparts and by means of facsimile or PDF signature, each of which once signed shall be deemed an original and all such counterparts shall constitute one and the same instrument.
