ASSIGNMENT AGREEMENT

THIS AGREEMENT, made and entered into as of this 28 day of July 2008, by and between:

CUBIS FINANCIAL, LTD., a limited liability company duly organized and existing under the laws of the State of Nevada and having its principal place of business at 325 E. Warm Springs Rd 2nd Floor, Las Vegas, NV 89119 ("**Cubis**");

Assignment

Cubis hereby assigns all of its rights, obligations, and liabilities of the trademark CASHBUZZ registration number 3186868, to Selling Source, and Selling Source hereby accepts such assignment ("Assignment").

As of the date of execution of this Agreement, Cubis shall have no further rights, obligations, and liabilities of any kind whatsoever to the above mentioned intellectual property.

Cubis warrants the following with regard to the property assigned herein:

1. Cubis is the owner of the property and there is not competing claims.
2. Cubis will not do any act which may prevent or hinder Selling Source from enforcing the assigned right.

Consent to Assignment

Pursuant to the foregoing terms and conditions, Selling Source hereby grants its consent to the Assignment and represents and warrants that it shall not raise any claim against Cubis in connection with the assigned right on or after the date of execution of this Agreement.



Any dispute or controversy arising from this Agreement shall be subject to the dispute resolution procedures provided for in the American Arbitration Association before the American Arbitration Association in the City of Las Vegas, State of Nevada. Any award shall be final and binding and judgment thereon may be entered in any court of competent jurisdiction. Nothing in this paragraph will be construed to preclude any party from seeking injunctive relief in order to protect its rights pending arbitration.

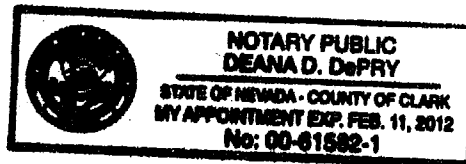
This Agreement contains the entire understanding among the Parties hereto with respect to the matters covered herein and supersedes and cancels any prior understanding with respect to the matters covered herein.

No changes, alterations or modifications hereto shall be effective unless made in writing and signed by all the Parties.



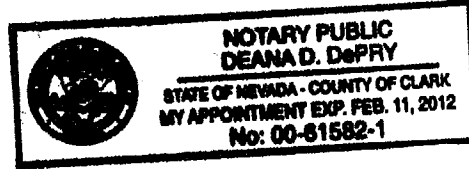


