ARTICLES OF INCORPORATION
WITH STATEMENT OF CONVERSION

I

The name of this Corporation is:

AFFLICTION, INC.

II

The purpose of this Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III

IV

This Corporation is authorized to issue only one class of stock and the total number of shares which this Corporation is authorized to issue is: Ten Million (10,000,000) shares at No Par Value.

V

The name of the converting California limited liability company is AFFLICTION, LLC. The limited liability company's California Secretary of State file number is 200521010068. The principal terms of the plan of conversion were approved by a vote of the members, which equaled or exceeded the vote required under Section 17540.3. There is one

class of members entitled to vote and the percentage vote required is a majority in interest of the members. The limited liability company is converting into a California stock corporation.

VI

The liability of the Directors of the Corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

VII

The Corporation is authorized to provide indemnification of agents (as defined in Section 317 of the Corporations Code) for breach of duty to the Corporation and its Stockholders through Bylaw provisions or through agreements with the agents, or both, in excess of the indemnification otherwise permitted by Section 317 of the Corporations Code, subject to the limits on such excess indemnification set forth in Section 204 of the Corporations Code.
