Pursuant to Section 251 of the General Corporation Law of the State of Delaware (the "General Corporation Law"), WorldGroup Consulting, Inc., a Delaware corporation, does hereby certify:

FIRST: That the names and state of incorporation of each of the constituent corporations are as follows:

SECOND: That an Agreement and Plan of Merger (the "Merger Agreement") pursuant to which Fiserv Merger Sub, Inc. will merge with and into WorldGroup Consulting, Inc. (the "Merger") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 251 of the General Corporation Law.

THIRD: That WorldGroup Consulting, Inc. shall be the surviving corporation (the "Surviving Corporation").

FOURTH: The Certificate of Incorporation of WorldGroup Consulting, Inc. is to be amended and changed by reason of the merger herein certified by striking out Article I thereof, relating to the name of the Surviving Corporation, and by substituting in lieu thereof the following article:

"Article I. The name of the corporation is Fiserv InsureWork, Inc."

and said Certificate of Incorporation as so amended and changed shall continue to be the Certificate of Incorporation of said surviving corporation until further amended and changed in accordance with the provisions of the General Corporation Law of the State of Delaware.

FIFTH: That the executed Merger Agreement is on file at the office of the Surviving Corporation, the address of which is 475 14th Street, Suite 850, Oakland, CA 94612.
