TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT, dated as of July 10, 2008 (this "Agreement"), is made by **MOTORSPORTS AUTHENTICS, LLC**, a Delaware limited liability company ("MA LLC"), **MOTORSPORTS AUTHENTICS, INC.**, a Delaware corporation ("MA Inc."), **GORACING.COM, INC.**, a Delaware corporation ("GRC"), **ACTION SPORTS IMAGE, L.L.C.**, a Delaware limited liability company ("Action Sports"), **MASS RETAIL CONCEPTS, LLC**, a Delaware limited liability company ("Mass Retail"), **RACING COLLECTABLES CLUB OF AMERICA, INC.**, a Delaware Corporation ("RCC") and **MOTORSPORTS TRACKSIDE, LLC**, a Delaware limited liability company ("MT LLC", and together with MA LLC, MA Inc., GRC, Action Sports, Mass Retail and RCC, collectively, the "Grantors", and each, a "Grantor"), in favor of **BANK OF AMERICA, N.A.**, in its capacity as administrative agent for each of the Lenders now or hereafter party to the Loan and Security Agreement (the "Agent").

RECITALS:

WHEREAS, the Grantors, the Agent and the lenders referred to therein have entered into that certain Loan and Security Agreement, dated as of the date hereof (as such agreement may be amended, amended and restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement"); and

WHEREAS, as collateral security for payment and performance by the Grantors of their Obligations, the Grantors are willing to grant to the Agent, for the benefit of the Agent and the Lenders, as the case may be, a security interest in certain of its personal property and assets pursuant to the terms of this Agreement, including, without limitation, the Collateral referred to in Section 2 below;

NOW, THEREFORE, in consideration of the above premises and in order to induce the Lenders to make Loans under the Loan and Security Agreement, Grantors hereby agree with the Agent for its benefit, and for the benefit of the Lenders, by acceptance hereof, as follows:

1. **Defined Terms.** All capitalized terms used but not otherwise defined in this Agreement have the meanings given to them in the Loan and Security Agreement. All other undefined terms contained in this Agreement, unless the context indicates otherwise, have the meanings provided for by the UCC to the extent the same are used or defined therein.

2. **Grant of Security.** As security for all Obligations, each Grantor hereby pledges, assigns, charges, mortgages, delivers, transfers and grants to the Agent, for the benefit of the Agent and the Lenders, a continuing first priority security interest in, lien on, and right of set-off against, all of such Grantor's right, title and interest in, to and under the following property and assets of such Grantor, whether now owned or existing or hereafter acquired or arising, regardless of where located (the "Collateral"):

(a) all of such Grantor's right, title and interest, whether now owned or hereafter acquired, in and to all United States and foreign trademarks, trade names, trade dress, service marks, trademark and service mark registrations, and applications for trademark or service mark registration and any renewals thereof (including without limitation each trademark

and service mark registration and application for registration identified in Schedule A attached hereto and incorporated herein by reference) and including all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto (including without limitation damages for past or future infringements thereof), the right to recover for all past, present and future infringements thereof, all rights corresponding thereto throughout the world (but only such rights as now exist or may come to exist under applicable local law) and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each trademark and service mark (collectively, the "Trademarks"); and

(b) any and all Proceeds of the foregoing.

3. **Recordation.** Grantors authorize and request that the Commissioner of Patents and Trademarks and any other applicable government officer record this Agreement.

4. **Execution in Counterparts.** This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

5. **Grants, Rights and Remedies.** This Agreement has been entered into in conjunction with the provisions of the Loan and Security Agreement. Grantors do hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Agent with respect to the Collateral are more fully set forth in the Loan and Security Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

6. **Governing Law.** **THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NORTH CAROLINA.**
