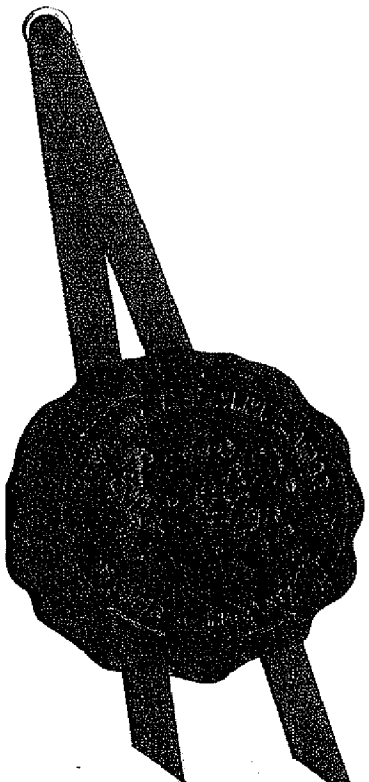

ORGANISATIE

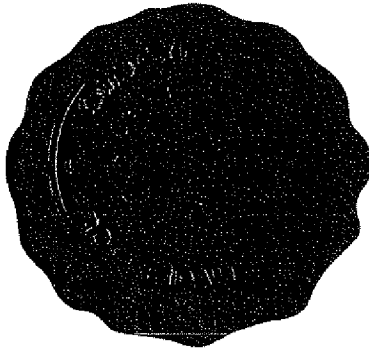
