RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated July 25, 2008 by Harris N.A., as successor by merger to Harris Trust and Savings Bank, as administrative agent for certain banks and other financial institutions (the "Agent");

WITNESSETH:

WHEREAS, the Agent, with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 and Life Line Screening of America Ltd., an Ohio limited liability company ("Debtor") with its principal place of business and mailing address at 5400 Transportation Boulevard, Garfield Heights, Ohio 44125 are parties to a certain Trademark Collateral Agreement dated March 1, 2005 which was recorded in the United States Patent and Trademark Office on March 1, 2005 at Reel 003051, Frame 0153, pursuant to which the Debtor granted a security interest in and collateral assignment to the Agent of certain trademarks, trademark registrations and trademark applications listed on Schedule A-1 attached hereto, trademark licenses listed on Schedule A-2 attached hereto, and certain other property (collectively, the "Trademarks"); and

WHEREAS, the Debtor has requested that the Agent release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages.
