**ASSIGNMENT OF
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

This ASSIGNMENT OF SECURITY INTEREST IN PATENTS AND TRADEMARKS is effective as of August 1, 2008, and is made by Hercules Technology Growth Capital, Inc., a Maryland corporation, with its principal place of business at 400 Hamilton Avenue, Suite 310, Palo Alto, CA 94301 ("Seller"), in favor of David Stiles of 20418 Iron Springs Road, Los Gatos, CA 95033 ("Purchaser").
