WHEREFORE, BIOJECT INC. has caused this Trademark Assignment to be duly executed below, on the date indicated, by its duly authorized officer.

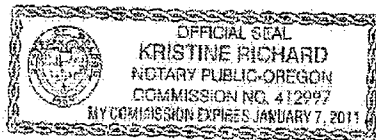
