

**Declaration for HUSH Trademark Registration**

The undersigned hereby declares under penalty of perjury that Medtronic, Inc. was always the correct owner of the HUSH trademark registration number 2,283,766. The previously recorded document, recorded with the Assignment Division of the U.S. Trademark Office on September 8, 2000, which assigned the HUSH registration from Leeds Media Group to Screenzone Media Networks, LLC, was submitted with erroneous information. The document should have recorded an assignment for registration number 2,283,763 for SCREEN ZONE instead.

The true chain of title for the HUSH trademark registration number 2,283,766 is that the trademark was always to remain in the name of Medtronic, Inc. The chain of title for the HUSH trademark registration number 2,283,766 should not be considered altered by the incorrect assignment. Neither Leeds Media Group nor Screenzone Media Networks, LLC were ever the proper owners of the registration.
