## RELEASE OF SECURITY INTEREST

### WITNESSETH

WHEREAS, the Company owns the trademarks and trademark applications described in the attached Schedule A (collectively, the "Trademarks");

WHEREAS, the Company owns the patents and patent applications described in the attached Schedule B (collectively, the "Patents");

WHEREAS, pursuant to the Guarantee and Collateral Agreement dated as of April 28, 2005 (the "Security Agreement"), the Company granted a security interest in the Trademarks and Patents to Agent to secure performance by the Company of its obligations to the Agent and the lenders;

WHEREAS, the Security Agreement was recorded in the Assignment Division, United States Patent and Trademark Office on May 18, 2005 at Reel 3119, Frame 0895 against the Trademarks;

WHEREAS, the Security Agreement was recorded in the Assignment Division, United States Patent and Trademark Office on May 18, 2005 at Reel 016245, Frame 0365 against the Patents; and

WHEREAS, Agent has agreed to release its security interest in the Patents and Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Release. The Agent hereby terminates, cancels, releases and reconveys to the Company any and all security interests it has against the Trademarks and Patents, without warranty or recourse. If and to the extent Agent has acquired any other right, title or interest in or to the Trademarks and Patents, it hereby assigns and transfers all such right, title and interest to the Company, including all goodwill associated therewith.

2. Further Assurances. The Agent agrees to execute, acknowledge, procure and deliver any further documents and to do such other actions as may be reasonably

requested by the Company to more fully effect the purposes of this Release, in each case at the Company's expense.

3. Counterparts. This Release may be executed in any number of counterparts, each of which need not contain the signature of more than one party but all such counterparts taken together shall constitute one and the same agreement.

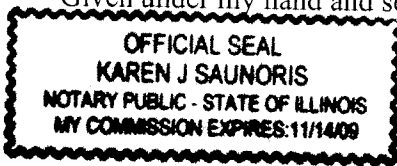
