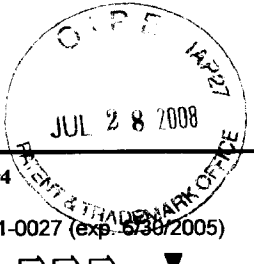

# RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARKS
