**THIS TRADE MARK ASSIGNMENT** is made the 30 day of March 2004

**BETWEEN**

(1) **ULTRA LABORATORIES LIMITED** a company incorporated in England under company number 02545010 whose registered office is at Tribune Drive, Sittingbourne, Kent, ME10 2PG, United Kingdom (hereinafter called "**the Assignor**"); and

(2) **SSL PRODUCTS LIMITED** a company incorporated in England under company number 01026788 whose registered office is at 35 New Bridge Street, London. EC4V 6BW, United Kingdom (hereinafter called "**the Assignee**")

**BACKGROUND**

A United States of America Trade Mark Registration No. 1042621 **LYOFOAM** in class 5, dated 06 July 1976 (hereinafter called "**the Trade Mark**").

B The Assignor has agreed to assign and transfer all legal and beneficial right title and interest in and to the Trade Mark and all goodwill that may have accrued to the Assignor by its use of the Trade Mark to the Assignee and the Assignee has agreed to accept such assignment, subject to and in accordance with the terms of this assignment.

**1. ASSIGNMENT**

1.1 For good and valuable consideration of the sum of £1.00, now paid by the Assignee to the Assignor (receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee:

1.1.1 all legal and beneficial rights, title and interest in and to the Trade Mark including any common law rights and for the avoidance of doubt all goodwill attributable and associated with the Trade Marks; and

1.1.2 the right to bring proceedings against any third party in respect of infringement of the Trade Mark or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks, including the right to claim damages or such other relief as may be available in respect thereof.

1.2 The Assignor hereby covenants that it will do at the expense of the Assignee all acts which may be necessary to confirm the title of the Assignee to the Trade Mark whether or not in connection with any registration of such title, and otherwise offer all necessary co-operation to have such assignments so effected and registered.

## 2. GOVERNING LAW AND JURISDICTION

The construction validity and performance of this assignment shall be governed in all respects by the laws of England and the parties hereto irrevocably submit to the exclusive jurisdiction of the English courts over any claim or matter arising from or in connection with this assignment or the legal relationship established by or in connection with this assignment.
