## TRADEMARK ASSIGNMENT

WHEREAS, Tribune License, Inc. (the “**Assignor**”), a Delaware corporation, has adopted and used and is the sole and exclusive owner of the trademarks, service marks and trade names and applications and registrations therefor listed in the attached Schedule A, and of all of the goodwill of the business appurtenant thereto (the “**Trademarks**”);

WHEREAS, Newsday, Inc. (the “**Assignee**”), a New York corporation is acquiring the Trademarks, together with all of the goodwill of the business associated with the Trademarks, from the Assignor pursuant to the terms set forth in that certain Redemption Agreement dated as of the date hereof (the “**Agreement**”), to which the Assignor and Assignee are parties; and

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for and in consideration of \$100 paid to it in hand and the amounts set forth in the Agreement, and other valuable and legally sufficient consideration, the receipt and legal sufficiency of which is hereby acknowledged, the Assignor hereby assigns and agrees as follows:

1. The Assignor hereby assigns, transfers, conveys and delivers to the Assignee all of its right, title and interest throughout the world in and to (a) each of the Trademarks, (b) all of the goodwill of the business symbolized by and associated with the Trademarks, (c) all applications and registrations for the Trademarks, (d) all rights to proceeds arising out of or relating to the Trademarks (including, without limitation, all claims, demands and causes of action (in law or in equity) for past, present and future damages arising out of or relating to infringement of the Trademarks); and (e) all rights to proceeds of the foregoing and all rights appurtenant to each of the Trademarks, including without limitation all claims that could be asserted by the Assignor against third parties arising out of or relating to the use or ownership of the Trademarks.

2. The Assignor hereby acknowledges and agrees that from and after the date hereof, the Assignee shall be the exclusive owner of the Trademarks.

3. The Assignor, for itself and its successors and assigns, upon the reasonable request of the Assignee shall, at its own expense, do, execute, acknowledge and deliver or cause to be done, executed, acknowledged and delivered, all such further acts, deeds, instruments, transfers and assurances as may be reasonably required by the Assignee in order to assign, transfer, set over and convey unto, and vest in, the Assignee, its respective successors and assigns, any or all of the Trademarks, and to put the Assignee in actual possession and operating control thereof, free and clear of all liens, charges, claims, pledges, security interests and other encumbrances, to assist the Assignee in exercising all rights with respect thereto and to assure the Assignee of the full benefits thereof. In addition, Assignor shall provide Assignee and its successors, assigns and their respective legal representatives reasonable cooperation and assistance in the prosecution or defense of any proceeding that may arise in connection with any of the rights assigned hereby. Such cooperation and assistance shall be at the Assignee’s sole cost and expense.

4. This Trademark Assignment shall be binding upon and shall inure to the benefit of the respective successors and assigns of the Assignor and the Assignee. This

Trademark Assignment shall not confer any rights or remedies upon any person other than the parties hereto, and their respective successors and assigns.

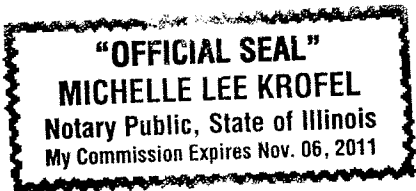
