RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release") is given as of this 21st day of July, 2008, by MONEYGRAM PAYMENT SYSTEMS, INC., a Delaware corporation, located at 1550 Utica Avenue South, Minneapolis, Minnesota 55416 ("Assignor"), in favor of ACE CASH EXPRESS, INC., a Texas corporation, with its chief executive office located at 1231 Greenway Drive, Suite 600, Irving, Texas 75308 ("Assignee").

WHEREAS, Assignor and Assignee entered into that certain Guarantee and Collateral Agreement, dated as of October 5, 2006 (as amended and restated, supplemented or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, Assignor and Assignee entered into that certain Intellectual Property Security Agreement, dated as of October 5, 2006 (the "Intellectual Property Security Agreement");

WHEREAS, the Intellectual Property Security Agreement was recorded with the U.S. Patent and Trademark Office on November 16, 2006, at Reel 003429/Frame 0907 and Reel 018528/Frame 0839;

WHEREAS, pursuant to the Collateral Agreement and the Intellectual Property Security Agreement, Assignee granted to Assignor a security interest in and agreed to assign, transfer and convey, upon demand made upon the occurrence and during the continuation of an Event of Default without requiring further action by either party and to be effective upon such demand, all of Assignee's right, title and interest in and to all of the Trademarks, including but not limited to the Trademarks set forth on Exhibit A attached hereto, and all of the Patents, including but not limited to the patents set forth on Exhibit B attached hereto (the "Intellectual Property Security Interest");

WHEREAS, the Parties desire that Assignor terminate and release its Intellectual Property Security Interest;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates, releases and discharges fully, the Intellectual Property Security Interest, and reassigns and transfers any and all interest that it may have in the Trademarks and Patents to Assignee.

Assignor hereby authorizes Assignee or Assignee's authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Intellectual Property Collateral, and/or (iii) otherwise file this Release.

Assignor further agrees to execute and deliver to Assignee any and all further documents and instruments, and do any and all further acts which Assignee (or its

agents or designees) reasonably requests in order to confirm this Release and Assignee's right, title, and interest in and to the Trademarks and Patents.

Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Intellectual Property Security Agreement or Collateral Agreement, as applicable.
