RELEASE OF LIEN ON TRADEMARKS

FOR VALUE RECEIVED, the undersigned, **ATLANTIC CAPITAL BANK**, a Georgia banking corporation, in its capacity as collateral and administrative agent under that certain Loan and Security Agreement dated October 30, 2007 (in such capacity, "Agent"), does hereby release, relinquish, discharge and convey to **AMERIPARK, INC.**, a Georgia corporation ("AmeriPark"), **MILE HI VALET SERVICE, INC.**, a Colorado corporation ("Mile Hi"), and **AMERIPARK NORTHEAST, LLC**, a Georgia limited liability company ("AmeriPark Northeast" and collectively with AmeriPark and Mile Hi, the "Assignees"), any and all right, title or interest that Agent has, or may have, in and to the trademark applications and the trademarks of the respective Assignees listed on Schedule A attached hereto pursuant to that certain Trademark Security Agreement dated October 30, 2007 (the "Security Agreement") among the Assignees and Agent, which was recorded on November 7, 2007, at Reel No. 3656, Frame 642 at the United States Patent and Trademark Office (altogether, the "Released Trademarks"), together with the goodwill of the business symbolized by the Released Trademarks and including, without limitation, all proceeds thereof (such as, by way of example only, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements and all rights corresponding thereto.

This Agreement is intended to operate as a release of all liens and security interests conveyed by Assignees to Agent in the Released Trademarks pursuant to the Security Agreement and to reassign to the respective Assignees all of Agent's right, title, and interest in and to the Released Trademarks.

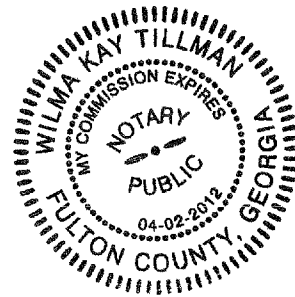
