TERMINATION OF SECURITY AGREEMENT

WHEREAS, BLONDER TONGUE LABORATORIES, INC. ("BTL"), Delaware corporation executed and delivered in favor of NATIONAL CITY BUSINESS CREDIT, INC., as agent (the "Agent"), that certain Security Agreement executed on December 28, 2005 and made effective on December 29, 2005 (the "Security Agreement"); and

WHEREAS, at the time the Security Agreement was executed, BTL was the owner of the trademarks and registrations therefor (the "Trademarks") listed on Schedule A hereto and the goodwill of BTL's business associated therewith; and

WHEREAS, pursuant to the Security Agreement recorded with the United States Patent and Trademark Office January 18, 2006 at Reel/Frame 003252/0105, BTL granted to the Agent, inter alia, a first priority security interest in and to the Trademarks, the registrations thereof, and the goodwill associated therewith; and

WHEREAS, the parties now desire to terminate the Agent's security interest in the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, the Agent hereby agrees as follows:

1. Effective as of the date hereof, the Security Agreement is hereby terminated, and of no further force or effect.
2. The Agent hereby releases its security interest and conveys back to BTL all of the Agent's interest in and to the Trademarks, the registrations thereof and the goodwill associated therewith.
3. The Agent agrees to execute such statements or other documents, as may from time to time be determined to be reasonably necessary, to evidence the release of any and all liens or interests of record in the Trademarks.

IN WITNESS WHEREOF, the undersigned has executed this Termination of Security Agreement as of this 6th day of August, 2008.
