Now, therefore, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Stephen F. Del Sesto, Esq. as and only as Receiver of Paragon and not individually ("Seller"), does hereby fully assign, transfer, and release unto Paragon RI LLC all of his right, title, and interest in and to the said Marks, including, but not limited to, all of his right, title, and interest in and to any pending applications, registrations and domain name registrations for such Marks, together with the goodwill of the business symbolized by the Marks.

Seller further assigns, transfers, and releases to Paragon RI LLC any and all claims for damages by reason of past, present, or future continuing infringement of said Marks, and the right to sue for and collect the same for its own use and benefit and that of its successors, assigns, or other legal representatives.
