## CERTIFICATE OF TRANSFER

THIS CERTIFICATE OF TRANSFER (this "Certificate") is made and entered into as of the 2<sup>nd</sup> day of November, 2006, by and between Guaranty Business Credit Corporation, a Delaware corporation (hereinafter referred to as "Transferor") and HB Bicycle Components, LLC, a Wisconsin corporation (hereinafter referred to as the "Transferee") (the words "Transferor" and "Transferee" to include their respective successors and assigns where the context requires or permits).

### WITNESSETH:

WHEREAS, Transferor has agreed to transfer and assign to Transferee pursuant to this Certificate and pursuant to Section 9617 of the Uniform Commercial Code of the State of California, all of Answer Products, Inc.'s (the "Debtor") right, title and interest in and to the trademarks, tradenames, domain names, rights under License Agreements and the goodwill of the business appurtenant thereto, as identified on Exhibit A, attached hereto and incorporated herein by reference (the "Marks");

WHEREAS, Transferor has the authority to sell and assign the Marks pursuant to and to the extent permitted by Article 9 of the Uniform Commercial Code of the State of California; and

WHEREAS, the indebtedness secured by the Marks is in default and Transferor has the right to foreclose upon and dispose of said Marks pursuant to and to the extent permitted by Article 9 of the Uniform Commercial Code of the State of California; and

WHEREAS, the Transferor wishes to sell and assign, and Transferee wishes to purchase, the Marks pursuant to this Certificate of Transfer.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Transferor, Transferor does hereby transfer, assign and set over unto Transferee all of the Debtor's right, title and interest in and to the Marks, including the registrations and common law rights therein, together with the good will of the business appurtenant thereto, and in and to any and all causes of action, either in law or in equity, and the right to enforce any rights and to file any causes of action, including the right to recover damages, for any past, present or future infringement or misappropriation of said marks, effective as of the date indicated below.

The Marks are being transferred by Transferor AS IS, WHERE IS, WITH ALL FAULTS, WITHOUT REPRESENTATIONS OR WARRANTIES OF ANY KIND OR NATURE, (EXCEPT AS SET FORTH IN AN ASSET PURCHASE AGREEMENT BETWEEN TRANSFEROR AND TRANSFEE OF EVEN DATA HEREWITH), INCLUDING WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, EXPRESS OR IMPLIED, ALL OF WHICH ARE SPECIFICALLY DISCLAIMED BY TRANSFEROR.
