TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "**Trademark Assignment**"), effective as of May 31, 2006 (the "**Effective Date**"), is by and between Harris Corporation, a Delaware corporation, with an office at 1025 West NASA Boulevard, Melbourne, Florida 32919 ("**Assignee**"), and Aastra Telecom U.S., Inc., a Delaware corporation, having an office at 1160 Route 22, Bridgewater, New Jersey 08807 ("**Assignor**").

RECITALS

A. WHEREAS, Assignor is a wholly-owned subsidiary of Aastra Technologies Limited, a Canadian corporation, with offices at 155 Snow Blvd., Concord, Ontario, Canada L4K 4N9 ("**Aastra Tech**");

B. WHEREAS, Aastra Tech has assigned certain assets with respect to its Aastra Digital Video unit business (the "**ADV Business**") to Assignor, including rights to certain trademarks and trademark registrations and common law trademarks as set forth on Appendix A hereto (the "**Assigned Marks**") and related goodwill;

C. WHEREAS, Assignor has sold certain assets and liabilities with respect to the ADV Business to Assignee;

D. WHEREAS, in furtherance of the foregoing sale of assets, Assignor desires to transfer, assign, convey, deliver and vest all of its right, title and interest in and to the Assigned Marks and all of the goodwill associated therewith;

NOW, THEREFORE, in consideration of the premises and for other good and valid consideration, the receipt and sufficiency of which are hereby acknowledged, the parties, intending to be legally bound, agree as follows:

Assignor, in accordance with the provisions of the Asset Purchase Agreement dated as of May 23, 2006 by and among Aastra Tech, Assignor, and Assignee, hereby transfers, conveys and assigns to Assignee all of Assignor's present right, title and interest in and to the Assigned Marks in the United States and throughout the world, any common law rights relating to the Assigned Marks, together with all of the assets and the goodwill of the business represented by the Assigned Marks, and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with any and all past, present or future infringements or dilution of or damage or injury to the Assigned Marks or such represented good will.

Assignor agrees that, upon reasonable request it will, at any time at Assignee's expense, execute such documents and take such further actions which may be reasonably necessary for evidencing the assignment of the Assigned Marks to Assignee.



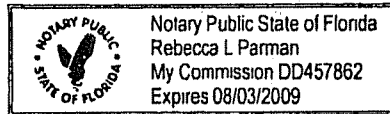


