Assignment

THIS ASSIGNMENT (this "Assignment") is made as of the 1st day of April, 2007 by Endo Pharmaceuticals Inc., a corporation organized and existing under the laws of Delaware, having offices located at 100 Endo Boulevard, Chadds Ford, PA 19317 ("Assignor") to Pacira Pharmaceuticals, Inc., a corporation organized and existing under the laws of the State of California, having offices located at 10450 Science Center Drive, San Diego, CA 92121 ("Assignee").

WHEREAS, Assignor and Assignee (in the name of SkyePharma, Inc. prior to changing its name to Pacira Pharmaceuticals, Inc.) entered into an agreement to terminate the Development and Marketing Strategic Alliance Agreement dated December 31, 2002 on February 12, 2007 (the "Termination Agreement") and that certain Transition Services Agreement dated March 8, 2007 related thereto (the "Transition Services Agreement"); and

WHEREAS, pursuant to the Termination Agreement and the Transition Services Agreement, Assignor agreed to transfer ownership to Assignee of (i) trademarks, trade names, and logos specific to the product or mark "DepoDur" worldwide, but specifically excluding any right to use the mark "Endo" (collectively, the "Trademarks"), (ii) domain names specific to the product or mark "DepoDur" (the "Domain Names"), and (iii) all of Assignor's right, title and interest in and to all copyrights, in all jurisdictions and whether or not registered, in and to all artwork and website content specific to DepoDur, the DepoDur Art (as defined in the Termination Agreement) and the DepoDur Marketing Materials (as defined in the Termination Agreement) (collectively, the "Copyrights").

NOW, THEREFORE, for good and valuable consideration in the amount of Ten Dollars (\$10.00), the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer, set over, and deliver to Assignee all rights, title and interest in and to:

- (i) the Trademarks and all foreign counterparts to the Trademarks, including, without limitation, all Trademarks set forth in Exhibit A hereto;
- (ii) the goodwill associated with the use of the Trademarks;
- (iii) the Domain Names;
- (iv) the Copyrights;
- (v) all rights of enforcement and the right to damages for past infringement, unfair competition or other conflicts relating to the Trademarks, Copyrights and Domain Names; and


(vi) all other rights, including common law rights, relating to the Trademarks, Copyrights and Domain Names to the extent such rights exist.

FURTHERMORE, Assignor will (i) execute and deliver such further instruments including further instruments of assignment; (ii) reasonably cooperate with Assignee to assign or convey rights or licenses that Assignor may have in and to copyrights in the DepoDur Art and DepoDur Materials to the extent that such copyrights are not owned by Assignor and such rights or licenses are assignable, and (iii) take such further actions as Assignee may reasonably request in order to register this Assignment at the appropriate registries and to effect, demonstrate, vest and record Assignee's title to the Trademarks, Copyright and Domain Names or in order to prosecute any of the pending applications included in the Trademarks.




