## TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Agreement"), dated as of August 11, 2008 (the "Effective Date"), is made by John O. Desmond, as Chapter 7 Trustee for the bankruptcy estate of GetConnected, Inc. ("Assignor") in favor of WhiteFence, Inc. (previously known as Qcorps Residential, Inc.), a Delaware corporation, with principal offices located at 5333 Westheimer Road., Suite 1000, Houston, TX 77056 ("Assignee").

WHEREAS, Assignor and Assignee entered into that certain Bill of Sale, dated October 23, 2007 (the "Bill of Sale"), pursuant to which Assignee purchased from Assignor certain Assets (as defined in the Bill of Sale) and where such Assets include certain trademarks and service marks of Assignor; and

WHEREAS, Assignee desires to document and fully perfect the assignment of such trademarks and service marks to Assignee for the purposes of registration in the United States Patent and Trademark Office, foreign trademark offices and elsewhere, as applicable, and Assignor desires to assist Assignee to fully perfect the assignment of such trademarks and service marks by the execution of this Agreement.

NOW THEREFORE, in consideration of the covenants made herein and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

1.0 Definitions. "Trademarks" shall mean the trademarks, trade names, service marks, trade dress, logos and corporate names included in the Assets, together with all translations, adaptations, derivations and combinations thereof, and including all goodwill associated therewith, and including, but not limited to, all applications, registrations, and renewals in connection therewith identified on Schedule A attached hereto and incorporated by reference herein.

2.0 Assignment. Assignor hereby assigns, sells, transfers and conveys to Assignee, its successors and assigns, all of Assignor's rights, title and interest throughout the world in and to the Trademarks, including all rights to sue or recover for the past, present and future infringement thereof. EXCEPT AS OTHERWISE EXPRESSLY SET FORTH HEREIN, ASSIGNEE ACKNOWLEDGES THAT ASSIGNOR'S RIGHT, TITLE AND INTEREST IN AND TO THE TRADEMARKS ARE BEING ASSIGNED TO ASSIGNEE "AS IS" AND "WHERE IS" WITHOUT ANY REPRESENTATIONS OR WARRANTY OF ANY KIND. Consistent with the Assignor's obligations under the Bill of Sale the Assignor shall execute and deliver such documents, prepared by Assignee at Assignee's expense, and allow Assignee to have access to documentation in the custody and possession of the Assignor as may be reasonably requested by Assignee from time to time but not later than December 31, 2008 to fully vest or perfect in Assignee all right, title and interest in and to the Trademarks.





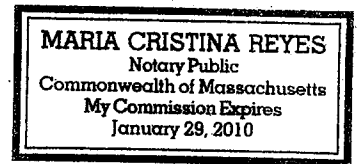
