## NOTICE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF SECURITY INTEREST IN TRADEMARKS is made the 20 day of June, 2008 by and between CHASE CAPITAL CORPORATION, (the "Lender") and GREAT LAKES KRAUT COMPANY, LLC, a Wisconsin limited liability company (the "Borrower").

The Borrower and the Lender acknowledge the following:

A. B. To secure the Secured Obligations, the Borrower has granted to the Lender a security interest in substantially all of its assets pursuant to the terms and conditions of a Pledge and Security Agreement dated as of the date hereof (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and among the Loan Parties and the Lender.

C. The Borrower owns the trademarks listed on Exhibit A attached hereto (the "Trademarks"), which Trademarks have been granted by, or applications therefor are pending before, the United States Patent and Trademark Office.

D. The Borrower has granted to the Lender a security interest in the Trademarks on the terms and conditions set forth in the Security Agreement.

E. Pursuant to the Security Agreement, the Borrower has granted to the Lender a security interest in and to the Trademarks and application therefor, now owned or from time to time after the date hereof owned or acquired by the Borrower, and in and to all proceeds and benefits thereof.


