

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Trust Assigned Trademark Owners hereby assign to the Company, their entire right, title and interest in and to the Trust Assigned Trademarks, including the goodwill of the business connected with the use of and symbolized by said marks, together with the right to recover for past infringement of said marks, and the right to seek registration of said marks anywhere in the United States or elsewhere in the world.






