**RELEASE AND TERMINATION OF SECURITY INTEREST**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST, dated as of this 21<sup>st</sup> day of July, 2008, is made by MERRILL LYNCH BUSINESS FINANCIAL SERVICES, INC., a Delaware corporation (the "Lender").

WHEREAS, US SALT, LLC, a Delaware limited liability company and its parent company, DEMETREE SALT, LLC, a Delaware limited liability company (collectively, with any guarantors, the "Company") granted a security interest (the "Security Interest") to the Lender pursuant to that certain Loan and Security Agreement (the "Security Agreement") dated July 7, 2004, and recorded in the records of the United States Patent & Trademark Office on August 3, 2004, at Reel 003035/Frame 0405;

WHEREAS, the Security Interest secured certain Obligations (as such term is defined in the Security Agreement) from the Company in favor of the Lender;

WHEREAS, the Company has satisfied and performed the Obligations and any other obligations under the Security Agreement in full; and

WHEREAS, the Lender has agreed to terminate and release the Security Interest in all of the Collateral (as such term is defined in the Security Agreement) of the Company, including, without limitation, the trademarks identified on Schedule 1 attached hereto.

NOW, THEREFORE, for valuable consideration, the Lender hereby terminates and releases the Security Interest and its entire mortgage, lien, encumbrance and security interest in all of the Collateral of the Company, including, without limitation, the following:

1. each trademark, trademark registration and trademark application of the Company, including, without limitation, the trademarks, trademark registrations and trademark applications referred to in Schedule 1 attached hereto and all licenses, general intangibles, intangible intellectual property or other similar property relating to the foregoing and all of the goodwill symbolized thereby;
2. the proceeds of any of the foregoing property;
3. each trademark license to which the Company is a party; and
4. any other Collateral as defined in the Security Agreement.

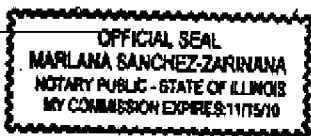
