WHEREAS:

1. Assignor has the authority to sell all right, title and interest of Canatal International Inc. ("Canatal") in and to the assets, property and undertaking of Canatal including, without limitation, those certain Trade-marks and registrations in the United States Patent and Trademark Office ("USPTO") and the Canadian Intellectual Property Office ("CIPO") and the Office for Harmonization in the International Market ("OAMI"), including the registrations set forth more fully in Schedules A, B and C together with the associated domain names canatal.com and canatal.ca and the goodwill in the trade name Canatal and any variation thereof, as set forth more fully in Schedule D, all attached hereto and incorporated by reference herein (collectively, the "Trade-marks");
2. Pursuant to an asset purchase agreement (the "Purchase Agreement") dated the date hereof between the Assignee and the Assignor, the Assignor agreed to sell and the Assignee agreed to purchase all of the Canatal's right, title and interest in the Trade-marks,
3. The Assignor and the Assignee wish to execute this assignment to permit the Assignee to be recorded as the owner of the Trade-marks.

**NOW THEREFORE THIS ASSIGNMENT WITNESSES** that for good and valuable consideration as set out in the Purchase Agreement now paid by or on behalf of the Assignee, the receipt and sufficiency of which are hereby acknowledged, the Assignor, hereby sells, assigns and transfers to the Assignee all of the Canatal's right, title and interest in and to the Trade-marks including, without limitation, all common law

rights connected with the Trade-marks, all applications filed to register the Trade-marks and all registrations issued from them, the goodwill in the Trade-marks, the right to market the goods under the Trade-marks using the same distinctive get-up and indicia as the Assignor has previously done, and the right to bring proceedings for past, present and future infringement of the Trade-marks, to hold unto the Assignee absolutely.
