ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

ASSIGNMENT dated as of August 11, 2008, from American Capital Financial Services, Inc., a Delaware corporation, as initial agent ("Agent") to The Bank of New York as successor agent (together with its successors and assigns, "Successor Agent").

WITNESSETH:

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of December 29, 2006 (the "IP Security Agreement") by and among American Home Laboratories, Inc., a California corporation, TestAmerica Analytical Testing Corp., a Delaware corporation, TestAmerica Air Emission Corp., a Delaware corporation, TestAmerica Environmental Microbiology Laboratory, Inc., a California corporation, TestAmerica Laboratories, Inc., a Delaware corporation (f/k/a Severn Trent Laboratories, Inc., a Delaware corporation), En Novative Technologies, Inc., a Delaware corporation, P&K Microbiology Services, Inc., a Delaware corporation, Q.E.D. Environmental Systems, Inc., a Michigan corporation, and Aerotech Laboratories, Inc., an Arizona corporation (individually and collectively, the "Grantor") and Agent, the Grantor granted a security interest to the Agent in certain IP Collateral; and

WHEREAS, the IP Security Agreement was recorded with the Patent Assignment Division of the United States Patent and Trademark Office on January 5, 2007, at Reel 018711 and Frame 0655; and

WHEREAS, the IP Security Agreement was recorded with the Trademark Assignment Division of the United States Patent and Trademark Office on January 8, 2007, at Reel 3456 and Frame 0285; and

WHEREAS, the Agent has assigned all of its rights, powers and privileges as agent under the Credit Agreement (as such term is defined in the IP Security Agreement) and the IP Security Agreement to Successor Agent; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Assignment, the Grantee hereby acknowledges and agrees as follows:

1. Definitions. The term "IP Collateral" as used herein, shall mean all of the Grantors' rights, title and interest of every kind and nature as of the date hereof in the Patents (including without limitation, those items listed on Schedule A hereto) and the Trademarks (including, without limitation, those items listed on Schedule B hereto). The terms "Patents" and "Trademarks" shall have the meanings provided by reference in the IP Security Agreement.

2. Assignment of Security Interest. The Agent hereby assigns all of its rights, powers and privileges under the IP Security Agreement to Successor Agent.

3. Further Assurances. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect this Assignment of Security Interest contemplated hereby.


